SO WHAT NOW

The elections are over and, due to the corruption that went on, we will never know who actually won. But what we do know is that our “Christian Nation” is about to turn its two most powerful political offices over to a couple of morally bankrupt and godless heretics. We can also expect that they will bring a steady stream of their kind into the government.

This is the time for us to remember that we’ve been here before. In 1993, Bill Clinton became president and appointed Janet Reno Attorney General. Then, within just a few days, they turned the FBI and the Department of Justice into a private police force for the abortion industry and launched a nationwide assault on the pro-life movement. And I can tell you from personal experience that nothing was off the table for these people – *legal or illegal*. But to its credit, the pro-life movement fought back and when the dust settled eight years later we had made more progress than at any time prior to that.

Right now, the future depends on how we respond to four realities. First, babies are still being killed. Second, the commitment you and I made to stop this holocaust is still in place. Third, the pro-life effort is in better shape today than it has ever been. And fourth, the wounds we suffered from this election will heal-up and hair-over if we don’t pick at them.

Before leaving this subject, I want to lighten the mood a little and give you a perspective on this election you may not have thought about.

When Jay Leno was hosting *The Tonight Show*, he often did a segment called JayWalking in which he would go out in public and ask people incredibly

simple –sometimes asinine – questions. The level of stupidity he identified could be breathtaking. In just one example, when he asked who the first woman on the Supreme Court was, more than one person said it was ... Judge Judy.

I recently saw someone online doing an Internet version of these “man-on-the-street” interviews and one of the questions he asked was, “*Is the Easter Bunny in the Old Testament or the New Testament?*”

It was alarming to see how many people addressed this as a legitimate question. **And these people are allowed to vote!** Think about that the next time you start to wonder how a Joe Biden becomes president.

PRO-LIFE VS. FAUX-LIFE

The pro-life position is that no action should be lawful if its intent is to take the life of an innocent human being. Based on the biological reality that a new human life is created at fertilization, the lives of the unborn should be protected by law at every stage of development, without exceptions and regardless of circumstances.

The problem is, this position is often compromised by people who claim to be pro-life, while at the same time saying that abortion should be legal in certain situations. To see how irrational this is, paraphrase their statements. For example, “*I am pro-life, but I think there should be an exception when the pregnancy was the result of rape*” becomes “*I am pro-life, but it’s okay to kill babies who were conceived in rape.*” Other paraphrased

positions would be, *“I am pro-life, but it should be legal to kill babies with Down Syndrome”* or *“I am pro-life, but killing babies in the first-trimester of pregnancy should be allowed.”*

Every exception can be paraphrased to reflect what is actually being said and, in doing so, it exposes the fact that there is no such thing as “Pro-Life With Exceptions.” By definition, it is a lie for someone who approves of killing any group of children to call themselves pro-life. It is as illogical as someone in 1860 saying, *“I am an abolitionist but I believe slavery should be legal in some circumstances.”*

Remember, the pro-life position is that an unborn child – at every stage of life – is morally equivalent to, and has the same right to life as, a five-year-old born child. So when someone says they are pro-life, but that abortion should be allowed in some circumstances, the question is whether they think it should be legal to kill a five-year-old in those same circumstances. If they don’t, then they clearly don’t see born and unborn children as morally equal and that exposes their claim to be pro-life as a fraud.

The bottom line is, “Pro-Life With Exceptions” is a combination of words that contradict each other – an oxymoron. What people are saying when they take this position is that they support the “choice” to kill some babies but oppose the “choice” to kill others. That makes them ***“Pro-Choice With Exceptions.”***

PREPARING THE NEXT GEN

When we attended the Turning Point USA Student Action Summit in Florida last December, there were about 5,000 attendees and during the four days of the convention we had interaction with almost all of them. We found them to be bright, energetic and engaged high school and college kids who, with few exceptions, self-identified as pro-life – even when they admitted that abortion wasn’t their main issue.

Unfortunately, even among those with the strongest pro-life commitment, most had an shocking lack of

knowledge and understanding of pro-life issues. In fact, many openly expressed to us that they knew that they did not know enough to effectively defend the pro-life position against either the pro-aborts on their campus or their liberal professors. Most said that when the subject comes up, they remain silent.

Many also expressed frustration about the almost total lack of support they get from the pro-life movement, including organizations that claim to exist specifically to serve their age group. In the past, we have gotten this same reaction from a lot of young people, and other pro-life leaders have told us that they have had similar experiences.

One small example of what’s driving this problem was seen in a recent social media post. Someone wrote that, *“To be pro-life is to be against elective abortion. No more and no less.”* This generated a lot of positive responses from pro-lifers with the most disturbing coming from the leader of a national organization that claims to educate and support pro-life students. Her reaction was a resounding and enthusiastic, *“Thank you!”*

Understand this: when someone says they oppose abortion, that does not necessarily mean that they support the right-to-life of the unborn. On many occasions, I have sat across a table from employees of high-volume abortion mills who said that they are against abortion. Similarly, pro-choice politicians routinely say that they are personally opposed to abortion – even as they pass legislation to keep it legal, right up to birth and paid for with tax dollars.

In a nutshell, the pro-choice gang has figured out that merely saying you are against abortion provides cover for the fact that you support it. They get away with this scam because even some pro-life leaders still don’t grasp the concept that someone’s position on abortion means nothing. All that matters is their position on the unborn. Simply put, is the unborn child a living human being entitled to have his or her life protected by law?

The distinction between opposition to abortion and

support for the unborn is not a mere technicality. It is at the core of the pro-life movement and if we fail to educate the next generation on this – and other – fundamental realities, our efforts are doomed.

RoeBots – those who blindly defend *Roe vs. Wade* – say that what others believe about abortion is irrelevant. All that matters is what the woman believes. If she doesn't think abortion is wrong, then it isn't wrong and no one has the right to tell her she can't have one.

In other words, it doesn't matter whether abortion is murder or not as long as the person who wants one says it isn't murder. By that logic, the Ku Klux Klan should be allowed to legally kill African-Americans as long as they claim to believe that black people are not really human beings.

Hollywood is Clueless

When this war began, the abortion lobby was certain that the legalization of abortion would eventually eradicate the stigma that has always been associated with it. But as we now know, this “mainstreaming” never took place – either in the general population or in the medical community. In fact, I would argue that, since the legalization of abortion, its stigma has actually increased and become more widespread.

This happened because the pro-life movement forced the abortion issue into the American consciousness and then never allowed it to go away. From the beginning, our working principle has been that if the public is going to tolerate abortion, we are going to rub their noses in it. This means that, today, the American people know more about what abortion is and what it does than they ever have. In effect, we have not allowed the abortion lobby to put a “happy face” on the wholesale extermination of unborn children.

The result is that many in the pro-abortion camp are now openly stating that their most devastating failure has been their inability to remove the stigma associated with abortion. This is why so many pro-abortion organizations have changed their names to one that does not contain the word abortion.

What these people understand is that stigma not only impacts the legality of abortion, it has a direct bearing on who has abortions and who does them.

One of the abortion lobby’s campaigns to remove the stigma of abortion was seen a few years ago, when they began marketing t-shirts with “*I had an abortion*” printed on the front. Of course it failed, but they keep trying. One of their latest strategies is to push the concept that there is no moral distinction

between one woman’s decision to have an abortion and another woman’s decision to give birth. Some of them are even trying to sell the idea that there are situations in which having an abortion is morally superior to giving birth.

What these people realize is that, if there was no stigma on abortion, the pro-life movement would be finished. In fact, it would have collapsed decades ago. Their problem is, every campaign they launch to get rid of this stigma goes down in flames. And the reason why is simple.



These efforts are doomed because abortion shares a fundamental and unchangeable characteristic with both pornography and prostitution. The stench coming from all three is indelible and cannot be either erased or reduced by simply making them legal. That’s why no mentally stable woman was ever proud of having an

abortion regardless of her political position on the issue. And no mentally stable woman ever climbed off an abortionist’s table feeling better about herself than she did when she climbed on it.

The stigma of abortion is so powerful it even effects those who work inside the abortion industry. We’ve interviewed abortion clinic employees who told us that they never tell anyone that they work at an abortion clinic, and that they take extra precautions to keep their friends and family from finding out. Some have told us that they insist their paycheck not have anything printed on it to indicate that it came from an abortion clinic.

In recent years, some abortion advocates have begun to openly question whether the stigma of abortion is so deep-rooted, even among women who actually have abortions, that it cannot be removed and is something they will just have to live with. The good news is, that’s up to us. The battle over stigma is ours to win, and as long as our rhetoric constantly reinforces that stigma, our enemies will have no defense against it.
