*“No man in the wrong can stand up against
a fellow that's in the right and
keeps on a-comin'.”*

That was said by William Jesse McDonald who, in 1891, became the head of the Texas Rangers. He served with distinction and was commonly referred to in law enforcement circles as “*a man who would charge hell with a bucket of water.*”

I think Captain McDonald would be proud of today's pro-life movement. After all, for almost fifty years, the “conventional wisdom” was that we were wasting our time because *Roe v. Wade* was settled law. The hopelessness of our situation was constantly reinforced by the fact that our enemies owned the media, academia, big tech, Hollywood, and the Democrat Party. Meanwhile, the abortion lobby was receiving boxcars full of money from the U.S. government, billionaire eugenicists, and giant multi-national corporations.

Making matters worse, the one group of people we should have been able to count on – the church – was being led by quislings who didn't have either the courage or the character to join the fight.

But even though the church abandoned the unborn, God didn't and neither did we. While we were often battered, bloodied, and bruised, we *kept on a comin'* and, on June 24th, what we had always been told would never happen ... happened. In a case titled *Dobbs v. Jackson Women's Health Organization*, *Roe* was tossed into the cesspool of history where it always belonged. It was a victory so improbable, and against such overwhelming odds, that only God could have delivered it and all the glory belongs to Him. But it should also be said that the pro-life

movement never stopped doing its duty.

Of course, we had all hoped that the Supreme Court would overturn *Roe* by ruling that legalized abortion violates the 14th Amendment. This would have established personhood for the unborn and ended this holocaust nationwide. Instead, they decided to punt and send the issue back to the states.

Let's make it clear that the *Dobbs* decision will save many unborn children from the horror of abortion. In fact, it is already doing so, and we have every right to celebrate that great victory.

But at the same time, we need to understand that the abysmal disgrace of *Roe* was that the Supreme Court labeled the unborn as non-persons who have no inherent right to life. What happened in *Dobbs* is that the right to make this decision was taken away from the Supreme Court and given to the states. In other words, the basic reasoning in *Roe* was retained in *Dobbs* and, for the unborn, the only real change is that a different group of people will be deciding whether they can be slaughtered or not.

My point is, we will not have achieved the ultimate victory until we arrive at personhood, and there is still a long and treacherous road ahead of us before we get there.

IT'S A “ROE-NO-MO” WORLD

Since January, 1973, the abortion battle has been one in which abortion policy was dictated by the Supreme Court and public opinion didn't count for much. But when *Roe* collapsed, the Supreme Court

basically took itself out of the picture and made public opinion the only thing that matters.

What this means is, with *Roe* out of the way this is now a grass-roots battle – and the pro-choice mob is clearly terrified that they cannot compete with us in that environment. For proof of that, just look how they reacted when the overturn of *Roe* was leaked. To put it mildly, these people came off the rails. In fact, most of them appeared to have experienced some sort of brain aneurysm.

The question is: Why all this drama? The Supreme Court didn't outlaw abortion, they just returned the issue to the state legislatures where it had been prior to *Roe*. To put it another way, they sent it back to the arena where the majority rules.

The abortion lobby's response was to start squealing that this is an outrage because 70 percent of the American people are pro-choice and support legalized abortion. Some of them claimed that this is true even in conservative states. Of course, their media stooges regurgitated these claims without any of that pesky "fact checking" business they find so all-important when it comes to Republicans, conservatives, and pro-lifers.

But think about it, if these people actually believe that the public is overwhelmingly pro-choice, why would they be running around with their hair on fire at the prospect of allowing the public to decide the country's policies on abortion?

The answer, of course, is that they are lying. They have always known that the "pro-choice majority" they keep chirping about doesn't exist. Remember, their definition of "choice" is that abortion should be legal through all nine months of pregnancy, for any reason whatsoever, for no reason whatsoever, paid for with tax dollars, and available to minor girls without their parents' knowledge.

They also know – as do their media lackies – that there has never been one poll taken in even the most radically pro-abortion state, that showed anything

close to majority support for that position. That's why the pro-choice mob has spent the last 50 years fighting to keep the abortion issue in the courts and out of the legislative process.

But on June 24th, they lost that fight. Deciding the nation's policies on abortion will no longer be an elitist privilege reserved for the abortion lobby's high-priced lawyers and hand-picked judges; it will be decided by the American people through the politicians they put in office.

ALL POLITICS IS LOCAL

It is tempting to believe that all political power resides in our state capitals and in Washington, DC, but the reality is that politicians only have the power that the voters give them. Be assured, if they thumb their noses at the people in their home districts, they will soon be reduced to looking for honest work.

What this means is, now that abortion has been taken out of the courts and put into the political process, the battle over abortion is going to be won or lost in our local communities. And as I said earlier, that's where we are the strongest. However, to have success in the future, we are going to have to become even stronger.

In order to meet this challenge, we have to strategize around two fundamental truths about American politics. First, no matter what the ruling class might say, there is no issue more important to them than getting re-elected. It controls every thought they have, every position they take, and every vote they make. Second, regardless of how pro-life a politician might claim to be, almost none of them are willing to walk the plank for the unborn. This is why, in the past, so many candidates who told us how pro-life they were when seeking our support, betrayed us once they were in office.

The point is, if we want the politicians we help elect to enact laws that protect the unborn, they have to feel comfortable that doing so won't get them thrown out of office. The only way to make them

feel that way is to increase the pro-life sentiment in the districts where they run for re-election.

However, that doesn't mean we have to turn every pro-choice voter into a pro-life voter in order to be successful. Remember, it doesn't really matter how many people tell some pollster that they are pro-choice. What matters is the number who are so rabidly pro-choice that they would never vote for a pro-life candidate, and that is actually a small percentage of those people who identify themselves as "pro-choice" in a poll.

In addition, that percentage drops every time we deliver a pro-life message that makes people who are marginally pro-choice, think about their position in a different way or feel a little less at ease with it. The bottom line is, we will never convert every one of these people to the pro-life position, but when we keep them from being single-issue pro-choice voters, we neutralize their impact.

What all this means is simple: starting right now, winning on the homefront has to be "Job One" for the pro-life movement. That is why Life Dynamics is currently working on a project designed to create a nationwide army of everyday pro-lifers who have been supplied with the knowledge, the tools, and the resources to win this battle in their own backyards.

Before going on, I want to make one final point.

In this new environment, the advantages our enemies have always had are not going away. They will still own the media, academia, big tech, Hollywood, and the Democrat Party. And they will still get billions from the government, the eugenics community, and giant multi-national corporations. And, of course, we can fully expect the church to continue hiding behind their mamas' skirts.

But what we learned on June 24th is that even those things are not enough to defeat us, as long as we work like everything depends on us and pray like everything depends on God. It is the only formula that can guarantee our victory.

SOME THINGS NEVER CHANGE

It's interesting that even the smallest pro-life groups have newsletters, while pro-abortion groups rarely have them. The reason why is simple. The media is their newsletter! After all, most of what the media puts out on abortion reads like it was written, edited, and approved by the abortion lobby – and in some cases it probably was.

Since *Roe* fell, this bias has produced an avalanche of stories about the disaster awaiting our hapless country if we tell mothers they can't hire a bunch of goons to murder their babies. To hear the media tell the story, it won't be long before America looks like a scene out of *Mad Max Beyond Thunderdome*.

The question is, if that is how America is going to be without legal abortion, why wasn't it like that before January of 1973? Remember, we don't have to speculate about what it's like to live in a country without legal abortion, we have many decades of real world experience to give us that answer.

Media bias was also on full display when Kansas became the first state to take up the abortion issue after *Roe*'s collapse. When a pro-life initiative there was defeated, the media's spin was that it was a total repudiation of the Supreme Court's decision. The message was that the pro-choice majority is still in charge even in what they characterized as a hardcore conservative red state.

But a few days after Kansas, Indiana passed a near total ban on abortion. Of course, that was largely ignored by the abortion lobby and the media. In fact, there were those in that camp who openly said that Kansas was a referendum on how the American people felt about abortion, but Indiana was not.

A new piece of legislation passed by congressional Democrats, and signed into law by the incoherent grifter in the White House, included funding for

Of course, immediately after *Roe* fell, that is exactly what started happening. For example, the abortion lobby in New Mexico is openly planning to become the “go to” spot for Texas women who want to have their children killed. But this “abortion tourism” doesn’t stop there. Mexico and Canada are also preparing to rake in American dollars from pro-life states that are near their borders. The Abortion Mecca

Don't be fooled by the abortion lobby's faux shock; June 24th was a day they had been long expecting – and they had a plan. For the past few years, they have been advocating and pushing legislation enshrining abortion in individual state constitutions in the hope of creating abortion havens in a post-*Roe* America. To anyone who thinks this sounds like the rantings of a tin-foil hat wearer, look at California.

California has always been known for its liberal abortion laws. For example, California has become the first state requiring public colleges to offer medication abortions at student health clinics. Come November, Californians will be voting on whether to enshrine the “*right to abortion and contraceptives*” in the state's Constitution. And this is just the beginning. There are 15 new bills that are currently moving through the legislature, based on 45 policy recommendations from the recently formed California Future of Abortion Council, comprised of notorious abortion industry power players such as Planned Parenthood and NARAL.

A few of the upcoming bills are designed with the goal of growing the waning abortion industry. SB 1375 would allow nurse practitioners to do first-trimester abortions without a doctor's supervision. AB 2626 opens California's doors to doctors who have been punished in another state for performing an abortion or “*an offense related solely to the performance of an abortion.*”

Their flagship bill is AB 1918, which would create the California Reproductive Health Service Corps

that would be responsible for recruiting and training abortionists. It would also oversee scholarships and loan repayment for those who attend a “*reproductive health professional school*” and agree to serve three years as a California abortionist.

In addition, the state's budget has allocated about \$200 million to “*reproductive health*” and \$20 million for “*scholarships and loan repayments to health care providers that commit to providing reproductive health care services.*” At the same time, millions more will go directly to abortion clinics. It's nothing more than an abortion industry stimulus package, and nobody is happier about it than Planned Parenthood. According to Vice News, the abortion giant is planning to build clinics near airports and along state lines.

For a state that has more debt than any other, the amount they are planning to invest in the abortion industry is staggering. Especially since state financial officials have stated that California could be collecting \$5 billion less in taxes than expected. Despite that, California seems intent on becoming the country's ultimate abortion destination.

The best evidence for this is AB 1242 and the recently passed AB 1666. AB 1242 would bar law enforcement agencies in California from “*cooperating with or providing information to an individual or agency from another state*” about any abortions occurring in California. Signed just after *Roe vs Wade* collapsed, AB 1666 nullifies civil judgements from other states against people who, not only seek abortions, but perform them.

And California isn't alone. In June, the governors of Washington, Oregon, and California announced “*a joint commitment to protect and expand reproductive rights along the west coast.*” It won't be long before other blue states with massive debt consider taking a gamble on “abortion tourism.”

She told me how excited she was because her two pro-life heroes were there: me and Bishop Bruskewitz. I advised her that I did not belong in the same league with him, but she insisted that I did.

She said that she had wanted to personally meet me, but was not able to get through the people who were standing around the dinner table where I was sitting.

This lady had the sweetest spirit about her I have ever encountered and talking to her was pure joy. But after we had talked for a while, she began to cry. Being a Southern Baptist, I wasn't quite sure what the Catholic protocol is for dealing with a crying nun, so I just stammered around for a while until I was finally forced to ask her why she was upset.

She needlessly apologized to me for becoming so emotional, and explained that she prayed every day that God would allow her to live long enough to see

an end to this nightmare. But she feared that, at her age, the answer was going to be "No."

We talked for a while longer and then agreed that we would stay in touch. But I never heard from her again. Not long after that conversation, another nun phoned to let me know that God had called Sister Elizabeth home. Turns out, she had been right all along ... the answer was "No."
